### **Practice content**

If the place of internship is laboratories, centers at the Faculty of Economics, academic and departmental research organizations related to solving economic, managerial, financial problems, independent analytical centers, departments of real business companies related to the collection and analysis of information, then *internship is conducted in the form of scientific research work*:

- carrying out a real research project, which can be related both to the development of a theoretical direction (method, methodology, model, etc.)
- conducting empirical studies, including statistical research, surveys, questionnaires
- participation in the research work of the department / laboratory, development by the student and publication of scientific publications, reports at various conferences (including intra-university ones)
- data preparation for compiling reviews, reports, scientific publications, etc.
- development of economic, mathematical and econometric models of the processes under study, phenomena and objects related to the professional sphere.

If the place of internship is academic and departmental research organizations, independent analytical centers, economic, financial, marketing and analytical services of companies of various industries and patterns of ownership, financial, credit and insurance institutions, government bodies at the federal, regional and municipal levels of government, then *internship is carried out in the form of internship in the field of professional activity:* 

- collection / refinement / expansion / refinement of information necessary for further research
- verification of hypotheses put forward, participation in solving specific practical problems or performing individual tasks for the host company / organization in agreement with its management,
- developing proposals for the development of methodology, methodology and organization of solving professional problems in the analyzed subject area,
- a preliminary assessment of the effectiveness of the developed proposals of practical and scientific, methodological nature,
- data preparation for reviews, reports and scientific publications, collection and systematization of reporting data and factual information for the calculational and analytical part of the master's thesis.
