The tuition costs shown are based on minimum enrollment for nine months (fall/spring) of study and do not include summer tuition. Living expenses are shown for 12 months.

² Please note that tuition is higher for the School of Public Policy and MBA Programs and will result in a higher total cost.

* Tuition may vary for graduate students holding assistantships. Stipends and benefits are determined by each academic department. You may use your stipend as partial proof of financial support. Please refer to your offer letter for award details.
